- Failure to pay the balance due within the specified term may result in termination of the contract without refund of any amount paid or deposited.
- NSF cheques will incur and additional fee of \$40.00
- A minimum deposit as outlined in the payment terms is required upon booking the booth(s)/Table(s). Payment in full is required by **March 10, 2017** for all purchase.
- The Exhibitor agrees to provide and offer product/services demonstration to the guest should they consent to participation.
- The Exhibitor shall not force the participation of any guest that declines to participate.
- All prizes donated to the show must be submitted to the producers by **March 15, 2017** to be included in the show script and onsite promotion of vendor prizes.
